SUBJECT: QUESTIONS, APPROVED PRODUCT SUBSTITUTION 1

1. Are we required to bid all (3) scopes of this project? Or can I price 1 or 2 scopes of the project?
 - a. *Bidders are required to submit pricing for all three scopes. The City will award entire scopes (not parts of scopes) based on available funding once bids are received.*

2. Refer to the Bid Price Schedule: Item No. 10 of the Airport Park Concession building corresponds to Structural Steel. However, upon review of the bid drawings there is no structural steel on this project. Same for item No. 8 of the dugout roofs. Please clarify.
 - a. *The Bid Price Schedule is a generic schedule of values. If there is no work included for a particular line item, then a bid amount is not required for that item.*

3. Are there two dugouts in this contract? Drawing A1.05 only shows one. Also, please confirm that the scope of work on the dugout(s) is limited to replacing the roof shingle with standing seam metal roof and related flashing, etc.
 - a. *There are four dugouts. The dugouts columns and exposed wood are to be painted, a minimum of 2 coats of paint.*

4. Can the 2 lifts of walking path be installed consecutively or do they want a delay between lifts?
 - a. *Density tests need to be performed on each base rock lift (4" max). Asphalt lifts can be installed consecutively but must include prime and tact coats.*


