4.-SPECIAL CONDITIONS**

**1. NOTE: IF THERE IS A CONFLICT BETWEEN THE GENERAL CONDITIONS, SPECIAL CONDITIONS, TECHNICAL SPECIFICATIONS, AND DRAWINGS, GENERAL CONDITIONS PARAGRAPH 3.4 ORDER OF PRECEDENCE SHALL CONTROL.**

**2. IF THERE IS A CONFLICT BETWEEN THE SECTION 01 NUMBER REFERENCES IN THE TECHNICAL SPECIFICATIONS AND THE GENERAL CONDITIONS, THE GENERAL CONDITIONS SHALL SUPERCEDE THE TECHNICAL SPECIFICATIONS.**

**3. CONTRACTOR understands and agrees to be subject to the "FDOT Small County Outreach Program (SCOP) Agreements/Rural Areas of Opportunity, FM#446249-1-54-01, as if it were the recipient thereunder. The SCOP Agreements require and the Contractor specifically agrees to the following:**

3.1 CONTRACTOR agrees that it will not discriminate against any employee employed in the performance of the Contract Documents, or against any applicant for employment because of age, ethnicity, race, religious belief, disability, national origin, or sex. CONTRACTOR shall provide a harassment-free workplace, with any allegation of harassment given priority attention and action by management. CONTRACTOR shall include a similar provision in all of its contracts and subcontracts made in connection with the performance of the Contract Documents and shall require the same of its contractors and subcontractors' contracts.

3.2 CONTRACTOR affirms that it is aware of and will abide by the provisions of section 287.134(2)(a), Florida Statutes regarding discriminatory vendors. CONTRACTOR agrees that it shall not violate section 287.134(2)(a), Florida Statutes, and acknowledges and agrees that placement on the list during the term of the Contract Documents may result in the termination of the Contract Documents. CONTRACTOR shall include a similar provision in all of its contracts and subcontracts made in connection with the performance of the Contract Documents and shall require the same of its contractors and subcontractors' contracts.

3.3 CONTRACTOR agrees that any of its contractors and subcontractors performing work or providing services in the performance of the Contract Documents shall utilize the U.S. Department of Homeland Security's E-Verify system to verify the employment eligibility of all new employees hired by the CONTRACTOR of any of its contractors and subcontractors during the term of the Contract Documents.

3.4 CONTRACTOR shall permit, and shall require its contractors and subcontractors to permit, the OWNER and the FDOT's authorized representatives to inspect all work, materials, payrolls, and records, and to audit the books, records, and accounts pertaining to the financing and development of this Project.

3.5 ~~If the Contract Documents involve compensation greater than \$250,000, CONTRACTOR certifies that it is prequalified by the FDOT pursuant to section 337.14, Florida Statutes and Chapter 14-22 of the Florida administrative Code. (If applicable to selected roadways.)~~ **NOT APPLICABLE**

3.6 In performing the requirements of this Article, CONTRACTOR shall adhere to the Florida Department of Transportation Standard Specifications for Road and Bridge Construction, latest edition, and Design Standards, latest edition and any applicable ordinances, statutes and regulations. **IF APPLICABLE**

3.7 "FDOT Small County Outreach Program (SCOP) Agreements/Rural Areas of Opportunity, FM# 444098-1-54-01, is incorporated herein by this reference as if fully set forth in full herein (including all exhibits, attachments and any amendments thereto) (hereinafter referred to as the "SCOP Agreements").

3.8 Florida Department of Transportation Standard Specifications for Road and Bridge Construction, latest edition (not attached hereto) is incorporated herein by reference and Florida Department of Transportation Design Standards, latest edition (not attached). **IF APPLICABLE**

3.9 The CONTRACTOR agrees to be bound by all the terms and conditions set forth in the Contract Documents. To the extent that a conflict exists between the SCOP Agreement and the remaining Contract Documents, the terms, conditions, covenants, and/or provisions of the SCOP Agreement shall prevail.
